Re: The Salvation Army - National Headquarters

Dear Sir or Madam:

We are general counsel to the National Headquarters of The Salvation Army. We understand that Throne Networks ("Throne") is the registrant of the "anus.com" domain name (the "Domain Name"), which identifies a web site that includes a likeness of The Salvation Army's registered "Red Shield" service mark (the "Web Site"). Print-outs from the Web Site and the Whois database are enclosed.

The Salvation Army name is incorporated in many service marks which have been registered with the United States Patent and Trademark Office, including the "Red Shield" service mark registered with the United States Patent and Trademark Office, Registration Number 807,044 on April 12, 1966, a copy of which is enclosed. It is clear from the mark on the Web Site, particularly from the style of the shield and the typography of the words "The Satanic Army" thereon (in lieu of "The Salvation Army"), that the design on the Web Site was directly copied from the registered "Red Shield" service mark of The Salvation Army.

Throne's unauthorized use of a likeness of The Salvation Army's registered service mark violates the rights of The Salvation Army under the Federal Trademark Act, the Federal Trademark Dilution Act, State unfair trade practices laws and the common law of unfair competition. In addition, the identification of The Salvation Army, an international religious and charitable organization and a branch of the Christian Church, with "Satan" on a publicly available Web Site is clearly defamatory.


On behalf of The Salvation Army, we demand Throne's immediate written assurance, in any event no later than November 17, 2006, that it has ceased and will desist from all use of the name or service marks of The Salvation Army, or any name or service marks likely to cause confusion with The Salvation Army, including the infringing mark.
